## DIAMOND JUBILEE

November 13, 1968, was a special day in the history of CANOPUS.

This day marked a "Diamond Jubilee" gala celebration in commemoration of three years commissioning (Nov. 4), two years on site in Rota (Oct. 10), and the completion of the 75th. refit on site to USS Thomas Edison.

CANOPUS, the fifth Polaris submarine tender, was built by the Ingalls Shipbuilding Corporation of Pascagoula, Mississippi. She was commissioned November 4, 1965, after joining Submarine Flotilla Six at Charleston, S.C.

Following commissioning and a shakedown cruise plus minor shipyard work, she moored in Norfolk, Va., to assist in the upkeep of Submarine Squadron Six. She then returned to Charleston, upkept submarines of SubRon Eighteen at the Cooper River site, and on September 9, 1966, she was relieved by USS Hunley (AS 31).

CANOPUS then got underway for Rota. She arrived here on October 10, 1966, and commenced refitting submarines of her present squadron, Submarine Squadron SIXTEEN.

Since her arrival in Rota, she has not only tended her own submarines, but has also given assistance when called upon to both the Atlantic and Mediterranean fleets. She has many "Atta Boys" and "thank yous" from many ships of the fleet.

CANOPUS will be deployed from Rota in April to undergo a yard period at Bremerton, Washington, Naval Shipyard, on the outskirts of Seattle, Washington.

CANOPUS is commanded by Captain Harold J. Trueblood, USN, and her Executive Officer is Commander Walter J. Kraus, USN.

#### The Sea Lawyer Cont.....

The following is an excerpt from the diary of one Charles Nordhoff, written during his tour of duty aboard USS Columbus from 1846-48.

"...On board ships, where, owing to the great number of men crowded together, it is impossible to guard one's property against theft, there is a public sentiment which makes theft the worst of crimes, and subjects the thief to a species of pillory, beside the punishment meted out at the gangway, which is as intolerable as anything can well be. Theft was of seldom occurrence on board our ship, there was but one individual caught "flagrante delicto" during the whole cruise of three years. He was found with several pieces of clothing in his clothes-bag, belonging to others. crime was plainly and patently proven on him; and then came the punishment. First, confinement in the brig, in irons, for two weeks; then a dozen (lashes) with the "thieves cat," an instrument made of heavier line than the common "cat," and soaked in stiff brine for a week before it is used, which makes each strand hard and stiff as a piece of wire; and, finally, he was sentenced to mess alone, and to wear upon his back, for six months, a placard containing, in conspicous letters, the word "thief"; and, in addition, made a perpetual member of the blacklist. Poor fellow, base as was his offense, his punishment was just. But no one molested him, and during the time he remained on board, he moved about among the ship's company shunned by all, and as much alone as though left upon a desert island. He was kept on board until the day before leaving our next port, when he disappeared, having received, it was said, an intimation to the effect, that if he could get ashore, he would not be sought for.

Let me point out that the policy that Mr. Nordhoff mentions at the close of his account is no longer in effect.

I hope the above transcript will caution all my shipmates to do what is required to keep those undesirables among us from enjoying the fruits of their dishonesty.



## Renowned Journalist Tours Canopus



On November 22, 1968, Miss Lisa Sergio, renowned lecturer and journalist, was the guest of CANOPUS.

Miss Sergio began her European tour in Rota as a guest of the European Council of Protestant Women and addressed the Fall Rally of the Protestant Women of the Chapel.

"father of radio".

commentator, world traveler, and lecturer and instructor at Columbia University.

Personnel whose names appear on the Master List may expect receive orders to Vietnam as vacancies in their ratings occur. If, on the other hand, you are no longer a volunteer want your name removed from the Volunteer List, submit a request via your commanding officer requesting moved.

## Pay Plan Cont....

Q. What are the basic objectives of the active duty compensation report?

A. One, to eliminate a complex pay system which prevents a member from determining the true value of his pay; second, to provide those who perform the same jobs with the same amount of pay, regardless of their marital status; third, to allow career personnel who do not stay in service until retirement to get back their contribution to the retirement system when they leave service; and last, to establish a method which would link military pay grades to comparable levels within the civilian economy through linkage with Civil Service.

. What are the major recommendations of this

report?

A. There are three: (1) to divide the military force into career and non-career segments; (2) to pay career force members a gross salary; and (3) to establish a direct relationship between military and Civil Service pay grades.

Q. Who are non-career members?

- A. All personnel in pay grades E-1, E-2, and E-3; all E-4's and E-5's with under two years of service; and all E-4's and E-5's with two to four years service but with less than six years total active duty obligation.
- Q. Who are the career members?
- A. All other enlisted personnel and all warrant and commissioned officers.

Q. How would non-careerists be paid?

A. Under the present system of pay and allowance.

Q. And the careerists?

- A. They would receive their pay by a gross salary system. Out of this salary, based on grade and years of service, one would provide for himself and his family (same salary, regardless of marital status) food, shelter, clothing and other necessities. He would also contribute to a retirement system and the entire salary would be taxable.
- Q. Suppose I leave service before I'm eligible for retirement?

A. Your contribution to the retirement system would be returned to you with interest.

## A Great Way to Watch TV

Washington (NavNews) ... Girl watching, favorite sport of our Navymen throughout the world, is usually restricted to in-port periods. Aboard the Navy hospital ship USS Sanctuary, operating with the Seventh Fleet, girl-watching is a part of everyday life, in port or at sea.

## HUBBELL PAY PLAN

Washington, (NavNews) ... (Ed. Note: This begins a question-answer series about the First Quadrennial Review of Military Compensation, better known as the "Hubbell Pay Plan." We invite any questions you may have about the revolutionary pay package now before Congress for "information," and will attempt to answer them in subsequent issues. Write: Editor, "The HELMSMAN" c/o Chaplain's Office, USS Canopus, (AS-34).

Q. What is the Hubbell Pay Plan?

It's a series of reports covering every aspect of military compensation. The first report deals with compensation, and is the only one completed to date.

- What is the purpose of the Hubbell Pay Plan?
- To keep qualified personnel in the service by making their salaries as attractive as those offered to persons doing similar work in civilian industry.

What will other reports cover?

Other reports will cover retirement benefits, survivor benefits, Reserve pay, and a variety of other special pays, such as flight and submarine pay, sea pay, hostile fire pay, etc.

Who's making the reports?

An all-service Department of Defense study group, headed by Rear Admiral Lester E. Hubbell, USN.

Q. Why are the reports being made?

A. Congress passed a law in 1965 requiring the President to begin a quadrennial (every four years) structural review of military compensation.

Q. When will the Hubbell Pay Plan go into ef-

fect?

- A. The present timetable calls for submission of the legislative proposal on active duty compensation early in January 1969. Congressional hearings on the proposal are expected to be lengthy, and final action is not expected before July 1, 1969, at the earliest.
- Since Congress has set July 1, 1969 as the date for an automatic military pay raise, would that mean military personnel would receive two pay raises if the Hubbell Plan goes into effect at that time?

A. The July 1 pay raise already on the books would be incorporated as a part of the total Hubbell Pay Plan if it were to pass and be put into effect at that time.

The exam writers at the Naval Examining Center at Great Lakes are required to use two publications as guidelines in exam preparation:

The Training Publication for Advancement (NavPers 10052) and the Manual of Qualifications for Advance-Rating (Navin 18068 series). Pers Both publications, which are revised annually, can be found in the Educational Services Office (2-80-10-Q). It is the responsibility of each candidate to know the material contained in both publications as applies to rating.

The Training Publications for Advancement lists the correspondence courses and other publications that an individual is required to or should study in preparing for advancement in rate.

After the candidate has ordered and received his training manuals, he should

check the first few pages to see if there is a "Reading List" of other Navy publications. These publications, which are referred to as secondary references, should be studied, for part of the exam could come from this material.

A candidate should also study material that is referred to throughout the text of basic training publications, for this material can also be used for testing purposes.

## **Cross - Currents**

Lieutenant, U. S. Navy Chaplain Corps No doubt you have heard and used the saying, "Procrastination is the thief of time." Here is the paragraph in which that sentence occurs:

"Procrastination is the thief of time; Year after year it steals, 'til all are fled, and to the mercies of a moment leaves the vast concerns of an eternal state. At thirty, man suspects himself a fool; knows it at forty, and reforms his plan; at fifty chides his infamous delay, pushes his prudent purpose to resolve; in all the magananimity of thought, resolves, and reresolves, then dies the same".

The author of this statement is an American lawyer named Owen D. Young. One gains from the thoughts the impression that procrastination is really the thief of more than time. It may well become the thief of character.

To put off action often shows indecision. Or it may indicate lack of will to follow a plainly marked path. A man can disintegrate under indecision.

Procrastination may reveal laziness, short-sightedness, disorganization, lack of self-discipline -- any or all of these.

It must be remembered, however, that there are times when we might act rashly in order to keep from procrastinating and find that we have acted very foolishly. It is one thing to think about something and never do it, yet quite another to act without any thought at all.

As in all of life, we must find a balance here. A great part of living is cultivating the wisdom to know when to act and when to delay action in order to gain clearer light on what should be done. Once we are sure, the next step is to make a decision, cut it off, and tie the knot. Loose ends do little to provide us with strong moorings.

Psalm 90:12 says:

"So teach us to number our days that we may apply our hearts unto wisdom." The wise old Bible gives us a good thought for the new year: "To number" means "to account for". We are, then, accountable for the use of our days. Time is given us to fill, not to kill. May this be the year in which we begin to do today what we could put off until tomorrow.

## Success....

Here lies the crux of the problem for a large percentage of personnel going up for advancement. They do not know what secondary references are used and that questions on such material can legally be used in an exam.

The second publication used by the item writer as a guideline in exam preparation, the Manual of Qualifications for Advancement in Rating, lists the practical and knowledge factors for each rate and rating.

A third class, for example, in checking the manual would find that he is responsible for and will be tested on the practical and knowledge factors at the third class level.

A first class going up for chief is responsible for the practical and knowledge factors for E-4 through E-7 and can possible be tested on any or all levels in the exam.

To be properly prepared for advancement examinations, a candidate should study all the required publications and secondary references and should know what is required in the way of knowledge and practical factors for the pay grade for which he is studying.

The period during which this law is in effect began February 28, 1961 and ends when so directed by Presidential Executive Order. It may be extended to include any period in which the armed forces are or were engaged in armed conflict with a hostile foreign force.
